Instructions for Tax Related Documents

2023 Tax Filers:

Direct IRS Transfer when completed the FAFSA

Important Note: As part of federal student aid eligibility, students, and spouses (as appropriate), will be required to consent and approve sharing and importing income and tax information from the IRS to the FAFSA form, even if the attempt to obtain or use such data is ineffective. In other words, if the student and spouse filed separate 2023 IRS income tax returns, both must provide consent and approval to share and import income and tax information from the IRS. In most cases, no further documentation is needed to verify 2023 income information that was transferred into the student's FAFSA using income and tax information directly from the IRS.

If 2023 income tax return information for the student (or spouse, if applicable) was not available or could not be used, the student should provide the institution with a 2023 IRS Tax Return Transcript(s) or a signed copy of the 2023 income tax return and applicable schedules.

Options for obtaining an IRS Tax Return Transcript

Important Note: The instructions below apply to each tax filer. If parents filed separate tax returns for 2023, you will need to provide an IRS Tax Return Transcript for each of them.

- Online Request Go to www.IRS.gov/transcript, and choose either "Individual Online Account" or "Get Transcript by Mail." Get transcript online will give you instant delivery via PDF whereas get transcript by mail will mail you a copy to be received within 5-10 days. Make sure to request the 2023 IRS Tax Return Transcript and NOT the 2023 IRS Tax Account Transcript.
- Telephone Request 1-800-908-9946, after following prompts, select option 2 to request a Tax Return Transcript (NOT Tax Account Transcript) and then enter "2023."
- ➤ Paper Request Form IRS Form 4506T-EZ complete the paper form and submit it to the IRS as instructed, being sure to use the correct fax number or address for your state of filing.

Amended Tax Returns (Uncommon): Tax filers who have amended their 2023 IRS tax return (e.g. corrections made to your 2023 tax return using Form 1040X) must send our office a signed copy of their 2023 IRS Tax Return Form 1040 and Schedules C & 1-3 (if filed), 2023 IRS Tax Return Transcript, or unaltered tax information directly transferred from the IRS (FA-DDX); and a signed copy of the 2023 IRS Form 1040X that was filed with the IRS.

Individuals Who Filed Non-IRS Income Tax Returns (Uncommon): A tax filer who filed an income tax return with a tax authority other than the IRS may provide a signed copy of his or her income tax return that was filed with the relevant tax authority. However, if we question the accuracy of the information on the signed copy of the income tax return, the tax filer must provide us with a copy of the tax account information issued by the relevant tax authority before verification can be completed.

Victims of IRS Identity Theft (Uncommon): Tax filers who are unable to obtain a tax return transcript or use the FA-DDX due to IRS Identity Theft must send our office a signed copy of their 2023 IRS Tax Return Form 1040 and Schedules C & 1-3 (if filed); and must also submit to our office a signed and dated statement indicating that they were victims of tax-related identity theft and that the IRS has been made aware of it, or an IRS 4674C letter (a letter from the IRS acknowledging the identify theft).

IRA Rollover (Uncommon): If you reported an IRA rollover on your 2023 IRS tax return, please provide a signed copy of your 2023 IRS Income Tax Return Form 1040 and Schedules C & 1-3 (if filed) clearly indicating there was a "rollover," as that information does not display on the Tax Return Transcript or from the direct data exchange with the IRS (FA-DDX).
